THE COURT, pursuant to the authority granted by North Carolina General Statute (G.S.) § 14-208.12A, devises and issues the attached recommended policies on requests for termination of sex offender registration.

NOW THEREFORE IT IS ORDERED that:

1. Petitions will be scheduled quarterly (January, April, July, and October) to be heard, when practicable, by the Senior Resident Superior Court Judge on the last day that cases are scheduled on his administrative week.
2. The petition must be filed 30 days prior to the session to make the docket. If not, then it will be scheduled for the next quarterly session. Notice shall be given by the Superior Court Manager at least 21 days before the hearing by using Exhibit A or some similar form.
3. Either party can seek to have the case continued. The parties are encouraged to seek consent for a continuance. If the parties do not agree, then the Court will resolve the dispute. To seek a continuance prior to the session, form AOC-CV-221, (Appendix H of Local Forms), should be used. Continuances once the session has begun are disfavored.
4. For the remainder of the year, the petitions will be scheduled on the following weeks of court: October 21, 2024 and December 16, 2024
5. The Office of the District Attorney should be served by the Petitioner.
6. The Office of the District Attorney should notify victims of the underlying offense.


