**ORDER**

Pursuant to the Findings of Fact above, IT IS HEREBY ORDERED:

1. The failure to appear identified in Finding No. 1 shall be stricken and any order for arrest identified in Finding No. 2, if still unserved, shall be recalled by the Clerk of Superior Court.
2. Further, pursuant to G.S. 15A-544.5(c) and the strike of the failure to appear and recall of any resulting order for arrest above,

 (for forfeitures initiated on or after Dec. 1, 2022) all bond forfeitures identified in Finding No. 3 are set aside.
3. Notwithstanding the Court's order setting aside the bond forfeiture(s) above, the defendant's further appearances in this criminal proceeding shall not continue to be secured by the bail bond(s) that was the subject of the forfeiture(s), for the following reasons:
