# Judicial District 42 Information and Scheduling Changes Effective July 1, 2024

#### District-wide:

- Odyssey/eCourts/Enterprise Justice/ICMS (Integrated Case Management System) will "Go Live" on July 22, 2024
- ATTORNEYS AND STAFF: PLEASE REGISTER FOR PORTAL AND FILE & SERVE TRAINING
- Judicial Assignment for <u>all pending and new domestic actions</u> (excluding 50Bs and absolute divorce) effective 7/1/2024
- No Notice/case limit restrictions for domestic calendars 7/1/2024-7/19/2024. However, cases MUST be noticed to the FIRST day of the session that begins with "Dom." Cases will be set on subsequent dates with judge initials only at the discretion of the Court.
- Civil court dates 7/22/2024 through AT LEAST 8/16/2024 will have daily case limits and the Court will specifically set matters during that time. If you anticipate needing a hearing during this specific time frame, it is recommended that you notice the matter for a status/scheduling conference between now and July 19, 2024.
- CVD sessions will be limited to general civil issues <u>only</u>: summary ejectments, collections, contracts, negligence, land disputes, jury trials, etc. Notice for the first day of the CVD term.
- Issues of Equitable Distribution and Alimony will be heard during domestic sessions with the assigned Judge.
- Alert the assigned Judge at the scheduling conference if it is anticipated that <u>any</u> issue will require >2 days for trial.
- Parties in custody actions are expected to complete Custody Mediation Orientation <u>prior</u> to the initial court date, or plan to appear on the initial court date and complete prerequisites prior to leaving the courthouse.

## **Henderson County:**

- ACH days should be utilized for returns on emergency matters, divorces, and other brief motions 7/1-7/19.
  From 7/22/24-8/16/24, ACH days shall be limited to returns on emergency matters.
- Days with judge initials in parenthesis: (LB) (AH) (JM) will NOT be in person court dates from July-September 2024. Instead, these dates will be utilized by those judges to set their trial order/trial list for the domestic session the following week based upon TIMELY SUBMITTED AVAILABILITY.
