PLEASE NOTE THE FOLLOWING CHANGES

1. Effective January 1, 2019, each week of Civil Court in Courtroom 3H will have both a Motions AND Jury Calendars. There will no longer be a week-long Motion session.
2. Pursuant to Rule 6(d) of Rules of Civil Procedure, "notice of hearing for motions must be served no later than 5 days before the time specified for the hearing". Therefore, the deadline for submitting your calendar request to the TCC will be 5pm on the Monday prior to your requested hearing date (**TCC must physically have calendar request by this deadline.** ****YOU WILL NEED TO EFILE YOUR NOTICE OF HEARING AND EMAIL YOUR CALENDAR REQUEST TO THE TCM.****)
3. Pursuant to Rule 5(a1) of Rules of Civil Procedure, all briefs and/or memoranda in support or opposition of motions must be submitted to the TCC 2 business days prior to the set hearing date.
